GITC PROJECT INDUSTRY UPDATE - FROM DSITI

Welcome to our updates on the Government Information Technology Contracting (GITC) framework refresh, we hope they help to answer your questions and provide you with the information you need to be ready to use the new ICT contracting framework for Queensland Government.

Since our last update, the Project Board has met on 20 April and 3 May. They were presented with status updates on the workshops to co-design the telecommunications services and as a service modules. Due to the significant amount of feedback and time to workshop these modules over the last few months, work to complete the contract documents is still progressing. We'll provide more information in the next update.

Now that the consultation to co-design the proposed new ICT contracting framework is nearly complete, we have started work to ensure that buyers and suppliers are aware of the changes and know what it means for them ahead of implementation.

Implementation of the new framework will commence before the end of the 2016/2017 financial year. This is when the new contract documents will 'go-live' and new contracts will start being made under the new framework.
